

If you're stopped/ taken by officers or federal agents 🚔

- You have the right to remain silent. If you are a minor, you need the presence of a parent. Give the card to the agent or officer.
- Stay calm. Do not run, argue, resist, or obstruct the police.
- Ask if you can leave. If yes, calmly walk away.
- You do not have to consent to a search of yourself or your belongings.
- Do not sign anything without speaking to your attorney.
- You have a right for a local phone call. The police cannot listen if you call your attorney.
- You have the right to a lawyer.

- Tienes derecho a un abogado.
